1. Summary

Raiffeisen Bank Kosovo is seeking a Professional and Reputable Service Provider / Contractor to provide with printing services necessary for the bank needs.

Please draft and submit your offer in accordance to the requirements as set below.

2. Financial Bid Requirements

2.1. Please submit the financial proposal for the requirements listed in Annex 1 (Offset print Specifications) and Annex 2 (Solvent Print Specifications) of this document.

2.2. All lines required within annex document must be completed in full, printed, signed and dated by the company's authorization person.

2.3. Bidders are allowed to submit their bids for a single, or both Annex's, as per their choice. It is a compulsory requirement that a bid is submitted for all individual lines within Annex. Partly completed Annex will be disqualified from the selection process.

2.4. All bids must be presented in Euros inclusive of VAT; in case that price is not specified the bank will consider that the price includes VAT.

2.5. Please provide material and print samples.



3. General Tender Requirement:

Offers must be presented in the following way:-

- Submitted in English language.
- Provide bidders full address and contact details.
- Provide bidders bank account details.
- Offer must have a number.
- Offer must be dated.
- Offers must show a valid until date. (Validity of the offer should be at least 90 days)
- Each page must be stamped and signed by company director.
- Business Registration Certificate (copy) must be enclosed.
- VAT Registration Certificate (copy) must be enclosed.
- Fiscal number Certificate (copy) must be enclosed.
- Company Organogram.
- Copy of Identification document (ID card, Passport or driving License) of the Company Owner.
- Provide list of machinery with specifications and extra machinery (if any).
- Provide material samples and print.
- Provide the list of raw material with specifications (origin of paper, pvc, vinyl, colors, etc) – applicable only for solvent based print.
- Delivery period for printing materials should be from two days to one week.
- Minimum three years of doing printing business.
- Three references from reputable institutions, confirming that the bidder has provided similar services, in relation to our requirements set on this document, must be enclosed. (Not older than three years)

4. Tender Terms and Conditions

- Documents must be placed in a sealed envelope and handed at the Security Desk at Raiffeisen Bank J.S.C, for attention of Legal Department, 51 UCK Street in Pristina. Tender ID Reference must be written on upper the right hand corner of the envelope, and the bidder's details on the lower right hand corner.
- Offer submission deadline is Tuesday 29th of June 2010 at 11:00 hours precisely.
- We reserve the rights to make amendments to the specifications, cancel this tender, re-invite the individual participants to resubmit their bid, disqualify a single bidder without giving notice or reasons.
- We reserve the rights to disregard / not enter into any type of correspondence with any bidding party at any time throughout the process.
