1. Summary

- 3) The rest of branches and sub-branches

2. Financial Bid Requirements

2.1. Please submit the financial bid for Evaluation of current power supply network for all RBKO Branches and Sub Branches.

2.2. All lines required within must be completed in full, printed, signed and dated by the company's authorization person.

2.3. All bids must be presented in Euros inclusive of VAT; in case that prices are not specified the bank will consider that the price includes VAT.

3. General Tender Requirements

3.1. Offers must be presented in the following way:

- Submitted in English language.
- Provide bidders full address and contact details.
- Provide bidders bank account details.
- Offer must have a number.
- Offer must be dated.
- Offers must show a valid until date. (Validity of the offer should be at least 90 days)
- Each page must be stamped and signed by company director.



- Business Registration Certificate (copy) must be enclosed.
- VAT Registration Certificate (copy) must be enclosed.
- Company Organogram (Minimum 3 Electrical Qualified Engineers are required)
- Copy of Certificate Licences / Authorization for Proceeding the above required Service.
- Company must show knowing and experience working with the listed standards, but not limited to:

(BS 7671, BS EN 50110 Parts 1 and 2, BS EN 60529, BS 5266 Parts 1 to 7, BS EN 62305, 4 parts, BS 7430).
- Copy of Identification document (ID Card, Pasport or Driving License) of the Company Owner.
- Fiscal number Certificate (copy) must be enclosed.
- Three references from reputable institutions, confirming that the bidder has provided similar services, in relation to our requirements set on this document, must be enclosed. (Not older than three years)

4. Tender Terms and Conditions

- Documents must be placed in a sealed envelope and handed at the Security Desk at Raiffeisen Bank J.S.C, for attention of Legal Department, 51 UCK Street in Pristina. Tender ID Reference must be written on upper the right hand corner of the envelope, and the bidder's details on the lower right hand corner.
- Offer submission deadline is Monday 28th of June 2010 at 11:00 hours precisely.
