- Provide bidders bank account details.
- Offer must have a number.

 - Offers must show a valid until date. (Validity of the offer should be at least 90 days)
 - Each page must be stamped and signed by company director.
 - Business Registration Certificate (copy) must be enclosed.



- VAT Registration Certificate (copy) must be enclosed.
- Fiscal number Certificate (copy) must be enclosed.
- Company Organogram.
- Copy of Identification document (ID card, Passport or driving License) of the Company Owner.
- Three references from reputable institutions, confirming that the bidder has provided similar services, in relation to our requirements set on this document, must be enclosed.(Not older than three years)
- Relevant Certificate that confirms origin for the product 1 (as per Annex 1)
